INTRODUCTION

Socio, Economic, Educational, Employment, Political and Caste Survey

(Comprehensive Door-to-Door Household Survey)

The Telangana Legislature on February 4, 2024 resolved to undertake a social, economic, educational, employment, political and caste survey (comprehensive Door-to-door household survey) in the state of Telangana as per the decision of the Council of Ministers.

The purpose of the survey is to make appropriate plans for implementation of various schemes to improve and provide social, economic educational, employment and political opportunities for development of Backward Classes, SC, ST and other weaker sections of the state.

The Planning Department has been appointed as the nodal department to conduct the survey. Instructions have been issued to complete the survey within period of (60) days.

4. Planning Department is designated as the Nodal Department for conducting the survey. The survey shall be completed within a period of (60) days.
5. Planning Department shall take further necessary action.
